- B. Presentations / Recognitions / Community Events
 - 1. Contra Costa College Update by Interim President Mojdeh Mehdizadeh

Interim President Mojdeh Mehdizadeh addressed Council regarding information on Contra Costa College and entered the presentation material into the record. Contra Costa College has served the communities since 1949 and recently completed their Strategic Plan 2020. Census and demographics information was presented. The current census is 10,119, sixty one percent of the students are 24 years of age or younger, and the majority are Latino, and are more female students. President Mehdizadeh discussed focus on strengthening community relationships and partnerships. Campus highlights include campus tours, outreach activities, concurrent enrollment (high school and college) Gateway to College Program, financial aid, sixty-two degree and forty-five certification programs, 200 committed employees and new learning spaces. New facilities constructed with Measure A funds will be opening in Fall 2016. She promoted their new restaurant, Aqua Terra, also opening in Fall 2016. Funding from Measure E will be used to construct a new science facility and health center, and modernize the gym annex, gym, locker room and other physical education facilities. President Mehdizadeh was available for questions.

Mayor Pro Tem Long asked about the ability to bring college courses to the high school.

Council Member Toms highlighted several excellent partnerships with Contra Costa College, including the use of pool facilities for high school water polo and swim programs, and the local Special Olympics use track facilities.

Council Member Murray asked about the array of evening classes. Mehdizadeh said the enrollment is much lower in the evenings and they are looking at ways to bring back creative dance and programs on a non-credit basis as there is a lot of interest among the 35+ age group.

Council Member Murray offered the use of the PCTV scroll.

<u>Bob Kopp</u>, Pinole citizen, said he attended the Culinary School and filmed the class. He complimented Chef Nadar and the lunch menu.

President Mojdeh Mehdizadeh highlighted the Food and Wine Event on April 24th, the Cupid Dinner Event on February 11th and provided contact information for the Culinary Department 510-235-7800.

6. CITIZENS TO BE HEARD (Public Comments)

The following citizens addressed the Council:

Bob Kopp, Pinole citizen, informed the Council that the BBQ Rib Cook Off will be in September on a date when the Senior Center is available.

<u>David Ruport</u>, Pinole citizen, addressed Council regarding the general procedural issues on the Verizon appeal, and indicated he was waiting for the letter from City Attorney Reyes.

Mayor Swearingen said the letter would be issued before the end of the week.

Mr. Ruport urged citizens to read the Telecommunications section of the code and also the Verizon Settlement agreement, which he cited in his December 22, 2015 letter

<u>Victor Berumen</u>, Pinole citizen, thanked Council Member Long for appealing the CVS Project. He said his property would be directly affected and the appeal would allow residents to better understand the project.

<u>Irma Ruport</u>, Pinole citizen, announced that the Verizon Appeal hearing would be held on February 9th at 7 PM and urged community attendance. She said the project should be brought to the public earlier, not at the 11th hour. A suggestion included hiring a part-time City attorney to review contracts and Ms. Ruport noted it was an election year and citizens wish to elect those who share their beliefs and ideals.

Vince Wells, Pinole citizen, addressed Council on unresolved, lingering issues:

- 1. Each engine company in Battalion 7 has a paramedic on the engine and explained in Pinole when a captain serves as a paramedic, they are not compensated for that degree.
- 2. The PERB Charge remains a huge issue and he hoped to work and negotiate with the Council, rather than wait for Board decision.

Mayor Swearingen responded that the City would like to meet, as well. .

9. OLD BUSINESS

A. Approve An Amendment To The Lease Agreement with Thomas Properties LLC Regarding the Gateway Project [Council Report No. 2016-17; Action: Adopt Resolution Per Staff Recommendation (Downs / De La Rosa)]

Hector De La Rosa, Assistant City Manager, presented Staff Report 2016-17 into the record. Background information was provided and he reported that the developer was moving forward on the conditions of the Lease agreement and obtaining signed agreements from all the taxing agencies, but were still waiting on the School District, the County and the Mosquito and Vector Control District, which are to be forth coming next week. The TKG Memorandum of Lease will be recorded this week and the developer needed to obtain title insurance. The last condition required the City to issue the Certificate of Occupancy for Sprouts to insure it would be built, before the sale would occur. The developer is asking to amend the condition due to the financing and wish to change it to allow purchase of the property prior to construction of the Sprouts Building. Thomas Properties has a signed lease agreement with Sprouts to support the need to construct the facility and Mr. De La Rosa verified seeing the lease agreement. It contains a condition that Thomas must provide a building to Sprouts by July 30, 2016.

Council Member Murray asked the City Attorney for a legal position.

Assistant City Attorney Downs said originally there were concerns with the developer getting entitlements and leaving the property fallow. At this point, coming off several years of a recession, banks have become more cautious of a lease position and have indicated it will be more expensive for the developer to construct with a leasehold rather than fee title. Downs said she does not believe fears that the property would remain fallow are still an issue.

Ms. Fitzer added that Sprouts was specifically named in four locations in the Development Agreement.

<u>Steve Thomas</u>, Thomas Properties, addressed Council and stated they are ready to start construction as soon as permits are issued. February 15th is their planned start date with completion by August 1, 2016. He spoke to their commitment to this project, which will be great for the community.

Mayor Pro Tem Long commended him for local outreach in the newspaper.

Mayor Swearingen asked if the secondary building would be built concurrently with Sprouts. Mr. Thomas confirmed that was the plan.

- B. Mayoral & Council Appointments
 - Select A Subcommittee To Conduct Planning Commission Interviews And Select Date For Interviews [Council Report No. 2016-18; Action: Receive Report – Council Discretion (Athenour)]

Mayor Pro Tem Long suggested Council Member Toms serve and Council Member Banuelos said he was also interested. There was consensus.

The date suggested by staff was accepted and interviews would be schedule don February 10, 2016 at 6 PM.

C. City Council Committee Reports & Communications

Council Member Banuelos reported on the WestCAT Lynx 10-Year Anniversary event which was held at the Bank of Pinole building on January 21, 2016.

Mayor Pro Tem Long reported that it was likely within the year West Cat would procure a grant for a double-decker bus, and possibly two. She said it is a very well run agency.

Mayor Swearingen reported that the Pinole Garden Club had advised him that the mural behind the bus stop at San Pablo Avenue and Quinan was in need of repair and that the bus stop was also very dirty and littered.

Mayor Pro Tem Long reported that she attended the January 25, 2016 Planning Commission Conditional Use Permit Hearing (CUP) for the cellular facility considered on the proposed CVS site on Appian. The Commission approved the CUP for the cellular facility and assigned a subcommittee to work on the design. She reported that she may need to appeal the CUP on the basis of the design only, as the 10-day appeal period as there would be no future option or no opportunity for an appeal following February 4th and the design would not be resolved by that time.

Council Member Toms said the design should come before the Planning Commission to be ratified and could be appealed at that time. Mayor Pro Tem Long said that was not the information she received from staff. If she can receive clarification in writing, she would not appeal by February 4th providing there would be an opportunity at the time of Planning Commission ratification. Mayor Pro Tem Long also stated that the City Attorney advised that both of her CVS appeals (project design and cell tower design) could be heard under one hearing.

Mayor Pro Tem Swearingen expressed concerned of the possible loss of the new store in Pinole, as well as the appeal process. He questioned whether an appeal by one Council member, should include the entire City Council as the appellant. He did not see language in the Code that states that and requested a legal opinion from the City Attorney.

Council Member Toms sad she thought it would be an appeal by an individual.

Mayor Pro Tem Long said she confirmed with the attorney, the appeal was limited to the points of her appeal only.

Council Member Toms reported that the ABAG General Assembly would be held on April 7 or April 14 at the Oakland Museum. Mayor Pro Tem Swearingen announced that he would not be in attendance as the Mayors' Conference Alternate. Council Member Banuelos confirmed he could attend as the City representative.

Council Member Murray reported that he would be attending a West Contra Costa Integrated Management Authority meeting next week. At the last meeting the board discussed restructuring the Joint Powers Authority (JPA), which will be a four to six month process and may have an impact on the region. Discussions will include topics such as what the JPA provides as a body and exiting the JPA. He also reported that the City of Richmond requested a pilot program for Richmond High School and found out that we do not partner with the WCCUSD but can ask them to do their share of recycling. No one from the District knew what the program entails and whether it counts toward our recycling numbers.

Council Member Toms said that some other cities have a lower fee, but also charge the actual costs to the developer.

Mayor Pro Tem Long reported that the Pinole and Martinez Animal Shelters were not accepting voluntary animal surrenders for a month, and will also offer \$29 adoptions.

- E. City Manager Report / Department Staff
 - 1. Rule 20A Update [Verbal Report Action: Receive Report (Fitzer)]

<u>Michelle Fitzer</u>, City Manager presented an update on the possibility of a Rule 20A Project companion project with Pinole Valley High School. In checking with PG&E regarding the viability, staff heard just today that it is viable for a companion project, should the Council be interested in pursuing.

There was Council consensus to agendize as soon as possible. Ms. Fitzer responded that the February 16 was a full agenda but if not possible to add, she would find another date.

<u>Hector De La Rosa</u> reported on the 30-year State Revolving Loan for the Wastewater Plant Upgrade project. He was notified that the State now requested a resolution with the specific dollar amount of the loan requested. The estimate is \$26,262,000.and the borrowing capacity is Pinole City Council

\$27.9 M borrowing capacity. Mr. De La Rosa said we would be moving forward with no deviations from the prior Council direction.

City Manager Fitzer said this was an administrative amendment, but wanted to make sue Council was aware.

F. City Attorney Report

There was no report.
