 - a. Proclamation presented to Patty Nichols and Elizabeth Whitford of the American Red Cross in Honor of American Red Cross Month

Mayor Long presented a Proclamation establishing March 2017 as American Red Cross Month in the City of Pinole.

Elizabeth Whitford, an American Red Cross Volunteer, accepted the Proclamation on the Organization's behalf and thanked Council for the recognition. She discussed the Red Cross' important work within our community.

- b. Proclamation presented to Officer of the Year Kyle Breckenridge

Mayor Long presented a proclamation to Officer Kyle Breckenridge. Officer Breckenridge thanked the community and Council for the recognition.

- c. Proclamation presented to Firefighter of the Year Captain Jim Brooks

Mayor Long presented a proclamation to Firefighter of the Year Captain Jim Brooks. Captain Brooks thanked the community and Council for the recognition.

B. Presentations / Recognitions

- a. Presentation of the West Contra Costa High-Capacity Transit Study by WCCTAC

John Nemeth, Director of WCCTAC, introduced Rebecca Kohlstrand, Project Manager, who provided the City Council with an update on the West Contra Costa High-Capacity Transit Study. Ms. Kohlstrand stated that the study was conducted to alleviate congestion on I-80 and BART. The study area includes the regional corridor I-80 and West County along San Pablo Avenue (southern to northern end). The study is advancing six alternatives such as Express Bus, Bus Rapid Transit (BRT); Commuter Rail and BART. All the information pertaining to this study will be available on the website for members of the public. Ms. Kohlstrand also requested 1) the Council provide feedback on the presentation 2) members of the public provide input to WCCTAC. She stated that WCCTAC will continue to do presentations to surrounding cities within the next few weeks. A draft WCCTAC plan will be presented to the Board in April for review.

Council members asked several questions and stated their concerns regarding proposed extensions at Appian Way/I-80 due to parking and site restrictions. They stated their desire to alleviate the current congestion at BART's El Cerrito del Norte service. Council expressed their appreciation for being able to provide input and noted that all projects will have a cost implication that may impact residents and it is important to inform the community.

The following speakers addressed the City Council:

Jack Meehan. Pinole citizen, addressed Council, expressed concern about future projects and asked Council to consider placement of project.

Keri Cummings. Pinole citizen, addressed Council, expressed her support and concern on imminent domain of the future placement of BART station at Appian Way.

b. Presentation on the Status of the Water Pollution Control Plant Upgrade Project

Tamara Miller, Director of Public Works provided an update on the Wastewater Pollution Control Plant Upgrade project. Council asked questions and received responses. Council thanked staff for their diligence and highlighted that the project has been running smoothly. Mayor Long responded to a citizen's request to review the Joint Powers Agreement between the City of Pinole and City of Hercules, Council will not be amending the contract at this time, due to current project construction. Council directed staff to place this contract for future review, after the project is complete.

6. CITIZENS TO BE HEARD (Public Comments)

Councilmember Toms stated her concern about not being in compliance with the Brown Act by not allowing members of the public to pull Consent Agenda items for comment. Mayor Long stated that she has consulted with the City Manager recently and that the action pertaining to public comment is consistent with policy as adopted by the majority of the Council.

Jack Meehan, Pinole citizen, addressed Council, to request clarification on definition of the Solid Waste Water Fund item 7E pages 66-89.

Andrea Miller, Finance Director, stated that this is a special revenue fund that receives revenue from Republic Services and WCCIMA for solid waste capital projects. It is not a sewer fund and the word "Water" will be removed the CAFR next year to reflect, "Solid Waste Fund".

- A. Discuss Traffic and Pedestrian Safety Committee recommendations and provide direction to staff

Development Services Director/City Engineer Tamara Miller presented the report and discussed the committee’s recommendations with Council. She stated that the Department of Public Works staff issued notifications to all potentially affected residents and businesses to provide an opportunity for public comment.

Council members asked questions and discussed their concerns with the proposed red curb installation at Pinole Valley Road and Rafaela Street, in specific how this action would affect residents of the area. Council requested that the proposed red curb on Pinole Valley Road at Rafaela Street be shortened to red curb at the corner of the intersection for minor impact to residents and businesses.

Matt Avery, Pinole citizen, addressed Council, stating his opposition to the installation of red curb at Pinole Valley Road and Rafaela Street.

Charles Anderson, representative of WESTCAT, addressed Council stating his support for the installation of red curb at San Pablo Avenue and Walter Avenue.
